### Practical Experience made with ISO 9001:2015

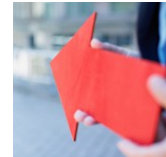

### Innovation with Quality - Designing the future by using ISO 9001:2015

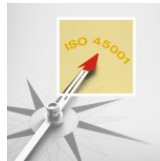

The period for submitting statements and voting for the DIS has expired on the 12<sup>th</sup> of May 2016. There was no sufficient agreement obtained by the national bodies (72% - yes, 75% are necessary); at the same time, more than 3.000 statements were submitted. This result requires the elaboration of a new DIS.
